

- **18 December 1830** LAND GRANT: **David D. Baker**, 50 acres in **Burke County**, North Carolina, on the waters of Cane Creek. (*North Carolina Land Grants, North Carolina Archives*, File No. 4804, Grant # 5460, Entry # 9555, 25 March 1828).
- **18 December 1830** LAND GRANT: **David Baker**, 50 acres in **Burke County**, North Carolina, on the waters of Cane Creek. (*North Carolina Land Grants*, *North Carolina Archives*, File No. 4843, Grant # 5499, Entry # 9454, 29 January 1828).
- **3 October 1831** LAND GRANT [ENTRY DATE]: **Bedford Wiseman**, 20 acres in **Burke County**, North Carolina, on the waters of the Toe River. (*North Carolina Land Grants, North Carolina Archives*, File No. 0650, Entry # 11,380).


Kathy Gunter Sullivan, a descendant of Reuben Young, reports that the exact date of Sophia Baker's marriage to Reuben Young, a widower with three children (Greenberry Wilson Young (1822-1898), Moses Young (1824-1906), and Mary Young (c1826-bef 1845)), is unknown but is presumed to be prior to the 1832 birth of their first

child. Documentation of the marriage includes two deeds, the first dated 23 May 1837 from David Baker to his daughter Sophia Young "for and in consideration of the paternal love and affection" (Yancey County Deed Book 3: 36-37), and the second dated 14 April 1848 in which Reuben and Sophia Young sold the property she received in the 1837 deed to E. J. Green (Yancey County Deed Book 3: 97-98). Reuben and Sophia Baker Young had seven children: David McDaniel Young (1832-1908), m. Martha A. E. Young; Thomas B. Young (1834-1909), m. Mary M. "Molly" Young; Susannah C. Young (1836-1929) m. John C. Blalock; Temperance A. Young (c1838-bef 1880 census); Dorothy E. Young (c1840-bef 1860 census); Nancy S. Young (1844-1895) m. Samuel W. Blalock; Reuben J. Young (1845-1932), m. Nancy Matilda Wiseman (a cousin, daughter of Alexander Wiseman and granddaughter of William Wiseman by his second wife Lydia Bedford). Sophia died 6 April 1891 in Mitchell County, NC. She is buried beside her husband, Reuben Young, at Green B. Young Cemetery in the Clarissa Community near Bakersville, Mitchell County.

- **14 January 1832** LAND GRANT: **Bedford Wiseman**, 100 acres in **Burke County**, North Carolina, on the waters of the Toe River adjoining Thomas Burlinson. (*North Carolina Land Grants, North Carolina Archives*, File No. 4922, Grant # 5577, Entry # 10,602, 27 September 1830).
- **20 December 1832** Land Grant: Reuben McKinney, 100 acres in **Burke County**, North Carolina, on Honeycuts Creek on North side of Toe River. (*North Carolina Land Grants, North Carolina Archives*, File No. 4954, Grant # 5610, Entry #5610, 29 December 1830).

Reuben McKinney was married to Mary Baker, sixth child and third daughter of David Baker by his first wife Mary Webb.

December 1833 — COUNTY LINES CHANGE: **Yancey County** was created from Burke and Buncombe Counties by an enabling act of the North Carolina General Assembly effective 1834.

26 January 1838 — WILL: **David Baker** executed his Last Will and Testament in Yancey County, North Carolina. It read:

In the Name of God Amen

I David Baker Senr. of the County of Yancey and State of N. Carolina (farmer). Being weak in Body but Perfect in Mind and Memory. Thanks be given unto God. Calling to Mind the Mortality of my Body and knowing that it is Appointed for all Men once to die, do make and ordain this My Last Will and Testament, that is to say principally and first of all I give and Recommend my Soul into the Hand of Almighty God that gave it and My Body I Recommend to the Earth to be buried in a decent Christian Burial at the Discretion of my Executors. Nothing Doubting but at the General Resurrection I shall receive the same again by the Mighty Power of God.

And as touches such Worldly Estate wherewith it has pleased God to Bless me in this life, I give devise and dispose of in the following manner & form, viz.

First I give and Bequeath to Dorothy My Dearly Beloved Wife all my Estate Both Real and Personal by her freely to be possessed of and Enjoyed during her Natural life and at her decease to be equally Divided between my Beloved Children (viz) Susannah, Martin, David, Dorothy, Josiah, Sophia and Charles.


To the rest of my children (viz) Elizabeth Baley, Thomas, William, Nancy Davenport, Critenden and Mary McKinney I give Nothing in consequence of having given them a Reasonable Portion of my Estate heretofore. I likewise constitute make and ordain David D. Baker and Josiah Baker the sole Executors of this my last will & Testament and I hereby disallow revoke and disannul every other former Testaments, wills, Legacies, Bequeaths and Executors by me in any wise before named willed and bequeathed. Ratifying & confirming this and no other to be my Last Will and Testament.

Note that the will lists all of David's known children by both his first wife Mary Webb (Elizabeth m. William Bailey, Thomas, William, Nancy m. Jonas Davenport, (James) Crittenden and Mary m. Reuben McKinney) and his second wife Dorothy Wiseman (Susannah m. Solomon Pitman, Martin, David, Dorothy m. David Davenport, Josiah, Sophia m. Reuben Young and Charles). It tends to disprove stories circulating on the Internet that Mary Webb Baker and several of her children died of milk fever (none of her known children failed to live to adulthood, and there is no gap in years among the children that would allow for an unknown child). It also disproves other stories that there were two additional children by Dorothy Wiseman Baker (Louisa and William, who were actually children of David and Dorothy's son Martin).

15 September 1838 – DEATH: **David Baker**, Yancey County, North Carolina. (*Family Bible of Josiah Baker*, son of David Baker, photographed 2003):



David Baker's second wife, Dorothy, was his cousin, a daughter of William and Mary Davenport Wiseman and granddaughter of Thomas Davenport. She outlived him by some 17 years, dying on 23 August 1855. Note that David Baker's estate took many years to settle, as reflected by this 1860 receipt from David's son Martin Alexander Baker to David D. Davenport, his brother and executor of their father's estate.
